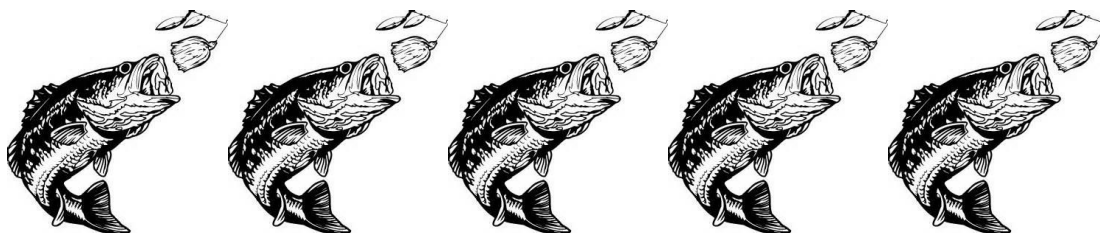
WEIGH-IN: SCALES WILL OPEN AT 2:00 PM, AND ALL FISH MUST BE BROUGHT TO THE SCALES FROM THE WATER BEFORE LOADING BOAT.

ALL TOURNAMENT CONTESTANTS ARE SUBJECT TO A POLYGRAPH TEST.

ALL STATE FISHING & BOATING REGULATIONS WILL APPLY. PLEASE DO NOT PUT DEAD FISH BACK IN THE WATER.

MORGAN CONCRETE FISHING TOURNAMENT RULES

- **FIVE FISH LIMIT. CULLING MUST BEGIN WHEN SIXTH FISH IS CAUGHT BEFORE EITHER CONTESTANT MAY RESUME FISHING. A 12" MINIMUM LENGTH WITH ONE DEAD FISH ALLOWED. NO CULLING AT THE WEIGH-IN SITE. IF YOU BRING MORE THAN FIVE FISH TO WEIGH IN, YOUR BOAT IS DISQUALIFIED.**
- FISH MUST BE LARGEMOUTH, COOSA, OR SPOTTED BASS.
- ALL LIVE-WELLS WILL BE INSPECTED DURING CHECK-IN.
- WE RESERVE THE RIGHT TO CHECK LIVEWELLS AT WEIGH-IN.
- ALL FISH WEIGHED IN AT TOURNAMENT MUST BE RELEASED AT WEIGH IN SITE.
- ONLY ARTIFICIAL BAIT MAY BE USED.
- EACH ANGLER MAY ONLY FISH WITH ONE ROD AT A TIME. NO DRAGGING OR DRIFTING.
- CONTESTANTS MUST STAY IN BOAT AT ALLTIMES WHILE FISHING.
- ALL BOATS MUST SHOW BOAT NUMBER TO CHECK-IN BOAT AT THE NO-WAKE BUOY AT THE TUGALO MEGA RAMP BY CHECK-IN TIME.
- LATE BOATS WILL RECEIVE A ONE POUND PENALTY FOR EACH MINUTE THEY ARE LATE FOR UP TO 10 MINUTES. AFTER 10 MINUTES, THE BOAT WILL BE DISQUALIFIED.
- IF A BOAT IS UNABLE TO RETURN TO THE WEIGH-IN DUE TO MECHANICAL PROBLEMS, THE TEAM HAS THREE OPTIONS: 1) ONE TEAM MEMBER WILL BE PERMITTED TO TRANSPORT FISH TO WEIGH-IN IN ANOTHER TOURNAMENT COMPETITOR'S BOAT. 2) THE TEAM CAN BE TOWED IN BY ANY OTHER BOAT. 3) CONTACT A TOURNAMENT OFFICIAL IF NEITHER OF THE FIRST TWO OPTIONS ARE AVAILABLE.
- **EACH BOAT MUST TRANSPORT FISH TO SCALES DIRECTLY FROM THE WATER BEFORE LOADING BOAT ON TRAILER. FISH BROUGHT TO SCALES FROM A BOAT ON TRAILER ARE AUTOMATICALLY DISQUALIFIED.**
- ALL LOCAL AND STATE FISHING LAWS MUST BE ABIDED BY, AND COMMON COURTESY MUST BE SHOWN TO ALL OTHER CONTESTANTS AND TOURNAMENT OFFICIALS. PLEASE DO NOT PUT DEAD FISH BACK IN THE WATER.
- NO UNDERWATER CAMERAS ARE ALLOWED DURING TOURNAMENT HOURS.
- FISH MUST BE CAUGHT BY MOUTH WHILE SITE FISHING FOR BEDDED FISH. FISH WILL BE CHECKED FOR EVIDENCE OF SNAGGING OR SNATCHING.
- ALL PROTESTS MUST BE MADE TO TOURNAMENT OFFICIALS DURING WEIGH-IN. ALL WEIGHTS ARE FINAL WHEN SCALES ARE ANNOUNCED CLOSED.
- WINNERS WILL BE DETERMINED BY TOTAL WEIGHT.
- IN CASE OF A TIE, TOTAL WEIGHT OR BIG FISH, THE PLACES WILL BE ADDED TOGETHER AND SPLIT EQUALLY.
- COMPETITORS MAY NOT COMMUNICATE WITH OTHER COMPETITORS, OR WITH OTHER BOATS ON THE LAKE, DURING TOURNAMENT HOURS FOR ANY REASON OTHER THAN AN EMERGENCY.
- ANYONE FOUND TO BE BREAKING TOURNAMENT RULES OR STATE REGULATIONS WILL BE DISQUALIFIED.
- ALL TOURNAMENT CONTESTANTS ARE SUBJECT TO A POLYGRAPH SCREENING, AND WILL ABIDE BY ITS OUTCOME WITHOUT QUESTION.

- LIFE JACKETS ARE NOT REQUIRED, BUT ARE RECOMMENDED, PER GEORGIA DNR REGULATIONS.
